## 1 Name

This instrument is the *Migration Legislation Amendment (Graduate Visas No. 2) Instrument (LIN 24/086) 2024*.

## 2 Commencement

This instrument commences immediately after the *Migration Amendment (Graduate Visas No. 2) Regulations 2024* commence.

## 3 Authority

This instrument is made under the following provisions of the *Migration Regulations 1994*:

- (a) subclause 485.231(1) of Schedule 2; and
- (b) subclause 485.231(2) of Schedule 2.

## 4 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

## Schedule 1—Amendments

### *Migration (Specification of Degrees) Instrument (LIN 24/048) 2024*

Omit “degrees”, substitute “degree”.

#### **2 Section 5**

Omit “each of the following degrees that are awarded as a qualification at level 7 or higher of the Australian Qualifications Framework is specified”, substitute “each degree is specified as follows, where that degree is awarded as a qualification at level 7 or higher of the Australian Qualifications Framework:”

Repeal paragraph 5(c).
